in a third-party funded EU research project entitled: "EMpowerment through liquid Integration of Migrant Youth in vulnerable conditions (MIMY)" **starting on 01 Feb. 2020**. The position is **limited until 31 Jan. 2023** with an average weekly working time of 20 hours. Payment is according to rates for German civil service employees (TV-L 13) in the federal state of North Rhine-Westphalia.

The MIMY project is funded by the EU Framework Programme for Research and Innovation. It examines how the integration of vulnerable, young migrants in European societies can be strengthened. The interdisciplinary Consortium consists of 12 research institutions in Europe. Based on a comparative case study approach, the project investigates the consequences of successful and failed integration; the factors influencing integration, especially of young migrants; and the role of different actors and institutions. Within the project the ILS is mainly responsible for studying the role and attitudes of the local population.
